The Texas Department of Public Safety has changed its procedure in regard to the way criminal history record checks will be submitted. We will no longer be accepting requests and payments for Personal Criminal History Records (TXIReview), Adoptions (International/Domestic), or Immigrations and Visas. Fingerprint cards, FAST Passes and payments will now be mailed to MorphoTrust in Springfield, Illinois for electronic processing.

## **ADOPTION INSTRUCTIONS: (Domestic/International)**

### **FOR PERSONS NEEDING A CRIMINAL BACKGROUND CHECK FOR:**

#### **A. ADOPTION-Domestic/International – (If individual is out of state or out of country)**

1. Submit a completed fingerprint card – fingerprints can be obtained through local law enforcement agency.

The card must include: full legal name; date of birth; other names used (nicknames; maiden names; etc.) in the alias field; sex; race; Social Security number; and reason fingerprinted (Domestic or International Adoption); date fingerprints were taken; signature of technician taking the prints; and signature of the individual printed. All ten fingerprints are required.

2. Individual needs to go on-line at [www.txdps.state.tx.us](http://www.txdps.state.tx.us) in order to print out the appropriate instructions. Individual will then need to register their submission at [www.identogo.com](http://www.identogo.com). Results will be mailed to the address provided by the individual.

3. Submit the required fee – A fee of \$24.95 in the form of a check or money order made out to MorphoTrust is required for this process. (\$9.95 for electronic submission of fingerprints and \$15.00 for Texas check.)

### **FOR PERSONS NEEDING A CRIMINAL BACKGROUND CHECK FOR:**

#### **B. ADOPTION – Domestic/International – (If individual is in Texas)**

1. Individual needs to go on-line at [www.identogo.com](http://www.identogo.com) or call 1-888-467-2080 to set up an appointment to be fingerprinted by FAST (Fingerprint Applicant Services of Texas).

2. Individual should make sure to select "Domestic or International Adoption" for purpose of fingerprinting when making their appointment on-line. (Select "Texas"; Click on "On-line Scheduling"; Click on "Begin Registration"; Enter name; Click "GO"; Click on "All Others"; Click on "Option A"; Click on "No, I do not have a FAST fingerprint Pass"; Select "Domestic or International Adoption"; Click on "Next Step"; and continue to follow instructions. If making appointment by phone, the individual will need to tell the technician that they are being fingerprinted for "Domestic or International Adoption" purposes. This will insure that the individual will receive the notarized letters needed for adoption purposes. Results will be mailed to the address provided by the individual.

3. The cost of this service is \$24.95. (\$9.95 for fingerprinting and \$15.00 for the Texas check.)

**FOR PERSONS NEEDING A CRIMINAL BACKGROUND CHECK FOR:**

**C. ADOPTION – Domestic/International – (If individual is in Austin)**

1. Individual may go to the Denson Lobby located at 108 Denson in Austin to be fingerprinted by FAST (Fingerprint Applicant Services of Texas).

2. Individual should make sure to tell the technician at the Denson Lobby that they are being fingerprinted for "Adoption/International Adoption" purposes. This will insure that the individual will receive the notarized letters needed for International Adoption purposes. Results will be mailed to the address provided by the individual, or may be picked up after 3:00 o'clock the following day.

3. The cost of this service is \$24.95. (\$9.95 for fingerprinting and \$15.00 for the Texas check.)

***If individual needs a criminal history record check for purposes of the "Dream Act", the individual will most likely only have a matricula card and not the documentation required to be fingerprinted at any of the FAST locations in Texas or at the Denson Lobby. The "Dream Act" request will be handled as "Immigration"; however, the individual will need to mail the information directly to DPS for processing. (Refer to A above.)***

**PROCEDURE TO ACCESS CRIMINAL HISTORY RECORD INFORMATION (CHRI) FOR  
PERSON(S) SEEKING TO ADOPT A CHILD WITHIN THE UNITED STATES  
(DOMESTIC ADOPTION)**

In accordance with Texas Government Code, Section 411.128, a person seeking to adopt a child under Chapter 162, Family Code, who is ordered by the court to obtain the person's own criminal history record information (CHRI) from the Department of Public Safety under Section 162.0085 Family Code, shall request the information as provided by that section.

**FINGERPRINTS SUBMITTED ELECTRONICALLY TO DPS:** The DPS has entered into an exclusive contract with MorphoTrust USA to provide statewide electronic fingerprinting through DPS FAST locations operated by IdentoGO. Fingerprint Applicant Services of Texas (FAST) are available by scheduling an appointment on-line at [www.identogo.com](http://www.identogo.com) or by calling 1-888-467-2080. DPS FAST locations operated by IdentoGO are committed to a 98% classifiable rate which means quality prints, less rejections, and quick responses. The cost of this service is \$9.95 plus a \$15.00 fee for the CHRI. The results will be mailed to the address provided by the individual. If an additional copy of the CHRI is needed, contact the Criminal History Inquiry Unit at (512) 424-5079 Option 4.

**FINGERPRINTS SUBMITTED BY MAIL THROUGH MORPHOTRUST USA:** The individual or their authorized representative must submit a completed hard card FAST pass form with the individual's signature and fingerprint card to MorphoTrust USA. The results will be mailed to the designated recipient provided by the individual. If you have any questions, please call (512) 424-5079.

**1. REGISTER YOUR FINGERPRINT SUBMISSION:**
